

AIRFIELD INDEMNITY

INDEMNITY IN RESPECT OF USE OF NTSIRI PRIVATE NATURE RESERVE PROPERTY AS AIRCRAFT LANDING GROUND ("the airfield")

I, the undersigned, acting in my personal capacity / on behalf of and duly authorized by:

The Member and/or Owner and/or Operator of certain aircraft specified below ("the Aircraft")

Hereby acknowledge that I, on my own behalf and on behalf of the Member and/or Owner and/or Operator, use the private airfield situated on the property known as Ntsiri Nature Reserve ("the Reserve") entirely at my/our own risk. My/our use of the airfield signifies our unconditional and irrevocable acceptance of the terms set out in this document.

Use of the private airfield shall be deemed to include but not limited to, landing, taking off, taxiing, parking, loading, alighting, repairing, boarding or any other activity related to the aircraft

I/we acknowledge further that the airfield is in a wildlife area, is unlicensed, is unmanned, is unfenced and is not regularly maintained and that the use of the airfield, and the approaches to and departures from the airfield, may be hazardous to aircraft and/or their occupants. I/we acknowledge that neither the owners and/or directors and/or management and/or fellow members of the Reserve and/or the Umbabat Private Nature Reserve and/or any person (together the "Reserve Parties") give any warranties, representations or undertakings in regard to the suitability of the airfield and that the use thereof is entirely at the sole risk and responsibility of the member/owner/operator of the aircraft concerned.

I/we hereby indemnify and hold the Reserve Parties harmless against any claims, loss, damage or actions which may be brought by or against me/us or any other persons whatsoever, as a result of or in connection with the use of the airfield and/or the aircraft hangar by me/us. We undertake jointly and severally to meet all such claims or to contest them for our own account and our own cost including legal costs in this regard incurred by the Reserve on an attorney and client scale.

I/we undertake that the contents of this Indemnity undertaking have been advised to, and accepted by, the Insurers of the Aircraft and that such Insurers have agreed to waive any and all rights of recourse against the Reserve Parties howsoever such rights might arise.

I/we waive any and all claims of whatsoever cause or nature including negligence, howsoever arising which I/we might have against the reserve parties.

Without delegating from the generality of the foregoing, I/we acknowledge that the reserve parties shall not be liable to myself and/or any passengers and/or the owners/operators of the aircraft nor any of the dependants of the aforesaid parties for any injury, illness, harm, death, damage of whatsoever nature or cause including not limited to negligence.
