WAIVER AND INDEMNITY: (to be signed by all persons over 18 years of age; parents to sign on behalf children under the age of 18)

I/We, the undersigned, hereby acknowledge that the wildlife (mammals, reptiles and insects), on N'TSIRI Nature Reserve (*the Reserve*) constitutes a danger to all persons in *the Reserve*, regardless of whether or not such persons are in or adjacent to any structure or building, on foot or in any open or closed vehicle, accompanied or unaccompanied by an employee or officer of the management of *the Reserve*.

Hereby acting both for myself and for any person under 18 in my custody or control, waiver and abandon any claim of whatever nature, which may arise in my favour, whether in my personal capacity or in any representative capacity in respect of any person under 18 in my custody or control, howsoever arising, to any compensation in respect of any injury or death sustained by me or any person under 18 in my custody or control, or in respect of any loss or damage to property, whether fixed or movable, caused by or attributable to wildlife on *the Reserve*, or caused by or attributable to any act or omission by any employee or officer of the management of *the Reserve* in connection with any defective state of *the Reserve*. In particular the state of any roads, structures or buildings on *the Reserve*, including airstrips, hangers and the like, and in particular arising from any defect in the construction thereof or any defects in, or absence of repairs, renovations or maintenance thereof.

I/We hereby indemnify the owners BJB Share Block (Pty) Ltd, R'Krantz Share Block (Pty) Ltd, Colmos (Pty) Ltd and Ntsheli (Pty) Ltd, their directors, employees and officers of the management of *the Reserve* from time to time, against any award, whether in respect of capital or costs awarded by any Court in respect of any injury, death, loss or damage set forth above, suffered by me or any person under 18 in my custody or control.

I/We hereby undertake and agree that this Waiver and Indemnity shall be effective in respect of my visit to *the Reserve* about to commence and in respect of any future visits thereto and shall continue to be effective and operative until withdrawn by me on 30 (thirty) day's written notice to the directors of *the Reserve*.
